Vistra Corporate Services (HK) Limited, Vistra (Hong Kong) Limited, Vistra Incorporations (Hong Kong) Limited, Vistra Trust (Hong Kong) Limited or Vistra Alternative Investment Services (Hong Kong) Limited (in this Privacy Notice, 'Vistra", "us", "we" and "our") may be acting as the respective Data User of your personal data and, as part of the Vistra Group (meaning Vistra Group Holdings (BVI) III Limited, any of its current and future affiliated entities, or such other amalgamated or re-organised successor company of Vistra Group Holdings (BVI) III Limited), recognises our responsibilities in relation to the collection, holding, processing, use and/or transfer of personal data under the Personal Data (Privacy) Ordinance (Cap. 486) ("PDPO").

Vistra Corporate Services (HK) Limited、Vistra (Hong Kong) Limited、Vistra Incorporations (Hong Kong) Limited、Vistra Trust (Hong Kong) Limited 或 Vistra Alternative Investment Services (Hong Kong) Limited (在本私隱聲明中統稱「瑞致達」,「我們」、「我司」和「我們的」)可能作為閣下個人資料的資料用户,並且作為瑞致達集團(指 Vistra Group Holdings (BVI) III Limited、其當前和未來的任何關聯實體或其他合并或重组的繼受公司)的一部分,承認我們在根據《個人資料(私隱)條例》(第 486 章)收集、持有、處理、使用及/或傳輸個人資料方面的責任(「私隱條例」)。

Personal data will be collected by us only for lawful purposes and all practicable steps will be taken to ensure that personal data held by us is accurate. We shall moreover use all practicable steps to protect any personal data we hold against unauthorised or accidental access, processing, erasure, loss or use. If we engage a data processor to process any personal data held by us, we shall adopt contractual or other means to ensure that the data processor complies with the mentioned data security requirement. We shall only use personal data for the purposes for which your personal data was originally collected and as further detailed herein.

Should your account or relationship with us be cancelled or terminated at any time, we shall cease processing your personal data as soon as reasonably practicable following such cancellation or termination, provided that we may keep copies of your data as is reasonably required for archival purposes, for use in relation to any actual or potential dispute, for the purpose of compliance with applicable laws and regulations or for the purpose of enforcing any agreement we have with you, for protecting our rights, property or safety, or the rights, property or safety of our employees, and for performing or discharging any functions, obligations and responsibilities we may have.

Under the PDPO, you may have the right to:

How we process, handle and collect your data

We process, handle and collect your personal data in a number of ways, for example: 我們將以多種方式處理和收集閣下的個人資料,例如:

Marketing

營銷

We may from time to time send you marketing communications about similar services we provide to you, as well as other information in the form of alerts, newsletters and invitations to events or functions which we believe might be of interest to you.

我們可能會不時向閣下發送有關我們向閣下提供的類似服務的營銷資料,以及我們認為閣下可能感興趣的活動或功能的其他資料(以提醒、時事通訊和邀請承等形式)。

We may communicate this to you in a number of ways including by post, telephone, email, SMS or other digital channels.

If you receive marketing communications from us but do not wish to receive them in the future, you may opt out of receiving them at any time, free of charge, by the following applicable means: 如果閣下收到我們的營銷資料,但希望將來不再收到,閣下可以随時通過以下適用方式免費退訂:

- unsubscribing by following the "Reply To" instructions contained in the marketing text message;

- notifying us that you no longer wish to receive marketing communications when receiving our marketing calls; or

- contacting us at the Data Protection Officer address stated above to tell us that you no longer wish to receive marketing communication through any channel.

We may issue service-related announcements to you when necessary (e.g., new laws, regulations or compliance requirements). You may not be able to opt out of these announcements which are service-related and not promotional in nature.

Transfer and processing of your personal data outside Hong Kong 在香港境外傳輸和處理閣下的個人資料

We may transfer, store, or process your personal information in locations outside the Hong Kong SAR. Where the countries to which your personal information is transferred do not offer an equivalent level of protection for personal information to the laws of the Hong Kong SAR, we will ensure that appropriate safeguards and security measures are put in place. We will use appropriate data security safeguards, use contractual confidentiality terms and agreements with third parties, ensure that the jurisdiction has equivalent data protection laws, or seek your explicit consent to the transfer of your personal data to a place outside Hong Kong SAR. You may learn more on the Hong Kong Legislation website for section 33 of the PDPO with respect to using consent for the transfer of personal data outside Hong Kong SAR, which is not yet in force as of the current date.

我們可能會在香港特別行政區以外的地方傳輸、儲存或處理閣下的個人資料。如果接收閣下的個人資料的國家不對個人資料提供與香港特別行政區法律同等程度的保護,我們將確保採取適當的保障措施和安全措施。我們將採取適當的資料安全保障措施,根據合同保密條款和與第三方達成的協議,確保接收資料的司法管辖區有同等的資料保護法律,或將閣下的個人資料傳輸至香港特別行政區以外的地方之前徵求閣下的明確同意。你可以在香港立法網站上查找私隱條例第 33 條關於經過同意將個人資料傳輸至香港特別行政區以外的地方的資料,該條款截至當前日期尚未生效。

Retention of your data

保留閣下的資料

We will only retain your personal data for as long as we have a lawful reason to do so. Vistra will process and store the relevant personal data for the duration of our services or for the duration of the business relationship. Vistra may also store the data for processing in our local servers and Vistra

Group databases, or use third party Cloud vendors and data processors where we have contractual security measures and reassurances of enhanced security measures in place for as long as it is necessary or required in order to fulfil legal, contractual or statutory obligations or for the establishment, exercise or defence of legal claims, and in general where it has a legitimate interest for doing so. In particular:

我們只會在有合法理由的情況下保留閣下的個人資料。瑞致達將在我們提供服務期間或在業務關係存續期間處理和儲存相關個人資料。為了履行法律、合同或法定義務,或為了建立、行使或捍衛合法權利主張,並且在维護合法權益的一般情況下,瑞致達也可能將資料儲存在我們的本地服務器和瑞致達集團資料庫中進行處理,或聘請第三方雲供應商和資料處理者進行處理,在此情況下,我們會採取合同保密措施和增强安全措施。具體而言:

- where we have collected your personal data as required by anti-money laundering legislation, including for identification, screening and reporting, we will retain that personal data for five (5) years after the termination of our relationship, unless we are required to retain this information by another law or for the purposes of court proceedings; or 如果我們根據反洗錢立法的要求收集閣下的個人資料,包括:用於識別、篩選和報告,我們將在業務關係終止後的五(5)年內保留該個人資料,除非我們需要根據其他法律或出於法院訴訟目的保留該資料;或
- otherwise, we will in most cases retain your personal data for a period of seven years after the termination of our contractual or other relationship with you in case any claims arise out of the provision of our services to you.
